A Resolution confirming an award by the Board of Control authorizing the purchase of contracts for cyber liability and foreign travel liability insurance coverage for the County for a one-year term, from 7/1/17 to 7/1/18, for a total amount not to exceed \$19,370.65, payable through Wichert Insurance Services, Inc. dba Wichert Insurance, as a Best Practical Source, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2015-227, which authorized the County Executive to execute a professional service contract with Wichert Insurance Services, Inc. dba Wichert Insurance, subject to the approval of the Board of Control, to provide brokerage services for the County's property, liability and boiler and machinery insurance program, for a one-year term, from 7/1/15 through 6/30/16, in an amount not to exceed \$30,000.00, with two options to renew for an additional one-year term; and

WHEREAS, a Resolution confirming the award by the Board of Control of a renewal (second and final) and amendment of the aforementioned professional service contract is currently pending before this Council; and

WHEREAS, Council also previously adopted Resolution No. 2017-076, which confirmed an award by the Board of Control authorizing the purchase of contracts for various types of insurance, for a one-year term, from 4/15/17 through 4/14/18, in an amount not to exceed \$895,232.00, payable through Wichert Insurance Services, Inc. dba Wichert Insurance, as a Best Practical Source; and

WHEREAS, the County's insurance broker, Wichert Insurance Services, Inc. dba Wichert Insurance conducted a search on the County's behalf for cyber liability and foreign travel liability insurance coverage for the County for 2017-2018 and provided the insurance proposal attached to this Resolution as Exhibit A; and

WHEREAS, the Board of Control, at its meeting on June 7, 2017, authorized the purchase of contracts for cyber liability and foreign travel liability insurance coverage for the County for a one-year term, from 7/1/17 to 7/1/18, for a total amount not to exceed \$19,370.65, payable through Wichert Insurance Services, Inc. dba Wichert Insurance, as a Best Practical Source, subject to confirmation by County Council; and

WHEREAS, because Wichert Insurance Services, Inc. dba Wichert Insurance has been directly paid in excess of \$800,000.00, Council approval of the purchase of the aforementioned insurance contracts is necessary; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to confirm the award by the Board of Control authorizing the purchase of the aforementioned insurance contracts for a one-year term, from 7/1/17 to 7/1/18, for a total amount not to exceed \$19,370.65, payable through Wichert Insurance Services, Inc. dba Wichert Insurance, as a Best Practical Source;

SECTION 1

The award by the Board of Control the purchase of contracts for cyber liability and foreign travel liability insurance coverage for the County for a one-year term, from 7/1/17 to 7/1/18, for a total amount not to exceed \$19,370.65, payable through Wichert Insurance Services, Inc. dba Wichert Insurance, as a Best Practical Source, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated, is hereby confirmed and the County Executive is hereby authorized to execute any documents necessary to effect the purchase of said contracts.

SECTION 2

This Resolution is hereby declared to be an emergency in the interest of the health. safety and welfare of the citizens of the County of Summit and for the further reason that it is necessary to immediately authorize the execution of contracts for cyber liability and foreign travel liability insurance coverage for 2017-2018 effective 7/1/17.

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.
