A Resolution authorizing the County Executive to execute a real estate sales agreement with the Summit County Land Reutilization Corporation for the sale of County real property, Parcel No. 6702382, located at 1445 Frederick Boulevard, Akron, Ohio 44320, in Council District 4, for the amount of \$100,000.00, for the Executive, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2012-214, which established the Summit County Land Reutilization Corporation ("Land Bank"), in accordance with Chapters 1724 and 5722 of the Ohio Revised Code, and approving and authorizing the County Fiscal Officer to file the Articles of Incorporation for the Land Bank as a nonprofit corporation, and the Fiscal Officer subsequently filed the same on June 6, 2012; and

WHEREAS, Council subsequently adopted Resolution No. 2012-254, which designated the Land Bank as the agent for the reclamation, rehabilitation and reutilization of vacant, abandoned, tax-foreclosed and other real property within Summit County pursuant to Section 1724.10 (A)(2) of the Ohio Revised Code; and

WHEREAS, Section 177.16(e) of the Codified Ordinances of the County of Summit authorizes the sale of County-owned real property, or any part thereof, that is not necessary for County operations, upon the authorization of County Council, to the Land Bank without competitive bidding; and

WHEREAS, the County of Summit owns Parcel No. 6702382, located at 1445 Frederick Boulevard, Akron, Ohio 44320, in Council District 4 and owns the same on behalf of the Summit County Developmental Disabilities Board ("DD Board"); and

WHEREAS, the County Executive has determined that the aforementioned parcel is no longer needed for County operations, and has recommended that the same be sold to the Land Bank to be subsequently leased for use as a men's transitional housing facility; and

WHEREAS, the County wishes to sell Parcel No. 6702382, for the amount of \$100,000.00, to the Land Bank; and

WHEREAS, the sale of Parcel No. 6702382 to the Land Bank will allow the property to subsequently be used as a men's transitional facility, which serves a critical role in the County's fight against the opiate epidemic; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a real estate purchase agreement with the Land Bank for the sale of Parcel No. 6702382, located at 1445 Frederick Boulevard, Akron, Ohio 44320 for the aforementioned reason;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit. State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute a real estate purchase agreement with the Land Bank for the sale of a Parcel No. 6702382, located at 1445 Frederick Boulevard, Akron, Ohio 44320, in Council District 4, for the amount of \$100,000.00.

SECTION 2

Upon the sale of the aforementioned property, the County Fiscal Officer is hereby directed to earmark and distribute the proceeds of the sale for use by the Summit County Developmental Disabilities Board.

SECTION 3

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further purpose of immediately allowing the sale of Parcel No. 6702382 to the Land Bank to allow for its use as a men's transitional housing facility.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 5

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Codes.
