A Resolution confirming an award by the Board of Control of a renewal (second of four) of a purchase contract with Aramark Correctional Services, LLC, for detention center youth food services, for the period 7/1/17 through 6/30/18, for a total amount not to exceed \$200,000.00, for the Court of Common Pleas-Juvenile Division, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2015-263, which confirmed an award by the Board of Control of a purchase contract with Aramark Correctional Services, LLC, for detention center youth food services, for the period 7/1/15 to 6/30/16, with four options to renew for a one-year period, in an amount not to exceed \$2.869 per meal and \$.50 per snack, for a total estimated amount not to exceed \$300,000.00, for the Court of Common Pleas-Juvenile Division; and

WHEREAS, the Board of Control, at its meeting held June 7, 2017, awarded a renewal (second of four) of a purchase contract to Aramark Correctional Services, LLC, for detention center youth food services, for the period 7/1/17 through 6/30/18, in an amount not to exceed \$3.010 per meal (breakfast, lunch and dinner) and \$0.525 per snack, for a total amount not to exceed \$200,000.00, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned renewal (second of four) of a purchase contract with Aramark Correctional Services LLC is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a renewal (second of four) of a purchase contract to Aramark Correctional Services, LLC, for detention center youth food services, for the period 7/1/17 through 6/30/18, in an amount not to exceed \$3.010 per meal (breakfast, lunch and dinner) and \$0.525 per snack, for a total amount not to exceed \$200,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such renewal of a purchase contract.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately provide for detention center youth food services effective 7/1/17.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
