7 **A Resolution authorizing the County Executive to execute a renewal (fourth and final) of a**
8 **professional service contract with Keefe Commissary Network, L.L.C., subject to the**
9 **approval of the Board of Control, to operate the Jail Inmate Commissary at the Summit**
10 **County Jail, located at 205 E. Crosier St, Akron, Ohio 44311, in Council District 4, for the**
11 **period of 11/15/16 through 11/14/17, in an amount not to exceed the commission rate of**
12 **34.5%, for the Sheriff, and declaring an emergency.**

14 WHEREAS, County Council previously adopted Resolution No. 2012-367, which
15 approved a professional service contract with Keefe Commissary Network, L.L.C., to operate the
16 Jail Commissary at the Summit County Jail, located at 205 E. Crosier St, Akron, Ohio 44311, in
17 Council District 4, for a one-year period, with four options to renew for an additional one-year
18 period, in an amount not to exceed the highest jail commissary commission rate of 34.5%, for the
19 Sheriff; and

21 WHEREAS, the County and Keefe Commissary Network, L.L.C. wish to enter into a
22 renewal (fourth and final) of the professional service contract with Keefe Commissary Network,
23 LLC. to operate the Jail Inmate Commissary at the Summit County Jail, for the period of
24 11/15/16 through 11/14/17, in an amount not to exceed the commission rate of 34.5%; and

26 WHEREAS, it is necessary to authorize the County Executive to execute the
27 aforementioned renewal (fourth and final) of the professional service contract with Keefe
28 Commissary Network, L.L.C. to operate the Jail Inmate Commissary at the Summit County Jail,
29 subject to the approval of the Board of Control; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that is necessary and in the best interest of the County of Summit to authorize the Executive to
33 execute the aforementioned renewal (fourth and final) of the professional service contract with
34 Keefe Commissary Network, L.L.C. to operate the Jail Inmate Commissary at the Summit
35 County Jail, subject to the approval of the Board of Control;

37 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

42 The County Executive is hereby authorized to execute a renewal (fourth and final) of a
43 professional service contract with Keefe Commissary Network, L.L.C., subject to the approval of
44 the Board of Control, to operate the Jail Inmate Commissary at the Summit County Jail, located
45 at 205 E. Crosier St, Akron, Ohio 44311, in Council District 4, for the period of 11/15/16
46 through 11/14/17, in an amount not to exceed the commission rate of 34.5%.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.

24 121.22 of the Ohio Revised Code.

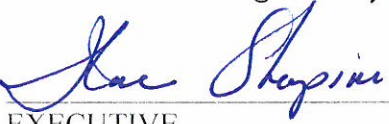
