7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
8 **with Summit County Children Services for the County Sheriff's Office to provide**
9 **telephone call answering services to Summit County Children Services, for a one-year**
10 **term, from 7/1/17 through 6/30/18, for a flat rate of \$26,500.00 per year, with two options to**
11 **renew for an additional one-year term, for the Sheriff, and declaring an emergency.**

13 WHEREAS, Summit County Children Services ("SCCS") wishes to execute an
14 intergovernmental agreement with the County for the County Sheriff's Office to provide
15 telephone call answering services to SCCS, for a one-year term, from 7/1/17 through 6/30/18, for
16 a flat rate of \$26,500.00 per year, billed in equal monthly installments of \$2,208.33, with two
17 options to renew for an additional one-year term; and

19 WHEREAS, the County wishes to continue to provide said services to SCCS through the
20 Sheriff's Office, which it has done so in previous years; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned intergovernmental agreement with SCCS is necessary and in the best
24 interest of the County of Summit;

26 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

29 SECTION 1

31 The County Executive is hereby authorized to execute an intergovernmental agreement
32 with Summit County Children Services ("SCCS") for the County Sheriff's Office to provide
33 telephone call answering services to SCCS, for a one-year term, from 7/1/17 through 6/30/18, for
34 a flat rate of \$26,500.00 per year, billed in equal monthly installments of \$2,208.33, with two
35 options to renew for an additional one-year term. The County Executive is hereby authorized to
36 execute the intergovernmental agreement in substantially the form attached to this Resolution as
37 Exhibit A.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit, and for the further reason to immediately
43 authorize the Sheriff's Office to provide telephone call answering services to SCCS commencing
44 7/1/17.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
