This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason that it is immediately necessary to appropriate the aforementioned Non-Emergency Medical Transportation pass-through dollars so that they may be immediately expended when received from the Ohio Department of Job and Family Services.
