7 **A Resolution appropriating funds, in the amount of \$1,100,000.00, in Non-Emergency**  
8 **Medical Transportation services pass-through dollars, for the Executive's Department of**  
9 **Job and Family Services, and declaring an emergency.**

11 WHEREAS, the County Executive's Department of Job and Family Service ("DJFS")  
12 coordinates and monitors the Non-Emergency Medical Transportation ("NET") services for  
13 eligible Summit County Medicaid clients through NET providers via portal-to-portal-to-portal  
14 transportation, which is funded by federal pass-through Medicaid dollars; and

16 WHEREAS, DJFS is receiving additional NET pass-through dollars from the Ohio  
17 Department of Job and Family Services funds, in the amount of \$1,100,000.00; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that it is necessary and in the best interest of the County of Summit to appropriate the  
21 aforementioned NET pass-through dollars, in the amount of \$1,100,000.00;

40 necessary to appropriate the aforementioned Non-Emergency Medical Transportation pass-  
41 through dollars so that they may be immediately expended when received from the Ohio  
42 Department of Job and Family Services.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.


