7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Asian Services in Action, Inc. to provide on-site employment services for**
9 **refugee clients participating in the Summit County Occupational Preparation Experience**
10 **program, for a one-year term, from 10/1/17 through 9/30/18, in an amount not to exceed**
11 **\$111,400.00, for the Executive's Department of Job and Family Services, and declaring an**
12 **emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 2, 2017, awarded a
15 professional service contract with Asian Services in Action, Inc. to provide on-site employment
16 services for refugee clients participating in the Summit County Occupational Preparation
17 Experience program at OhioMeansJobs Summit County, formerly known as the Job Center, for a
18 one-year term, from 10/1/17 through 9/30/18, in an amount not to exceed \$111,400.00, subject to
19 confirmation by County Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information
22 that the aforementioned professional service contract with Asian Services in Action, Inc. is
23 necessary and in the best interest of the County of Summit;

30 The award by the Board of Control of a professional service contract with Asian Services
31 in Action, Inc., for on-site employment services for refugee clients participating in the Summit
32 County Occupational Preparation Experience program at OhioMeansJobs Summit County,
33 formerly known as the Job Center, for a one-year term, from 10/1/17 through 9/30/18, in an
34 amount not to exceed \$111,400.00, is hereby confirmed and the County Executive is hereby
35 authorized to execute such professional service contract.
