A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of Summit, authorizing purchases by the County Executive from REXEL, as a Best Practical Source, for operations within the Executive's Department of Sanitary Sewer Services in calendar year 2017, in a total aggregate amount not to exceed \$100,000.00, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar year, where no additional competitive quotes or bids have been taken, shall be made only upon authorization of County Council; and

WHEREAS, the Department of Finance and Budget and the Board of Control have previously approved purchases by the County Executive from REXEL, as a Best Practical Source, for operations within the Executive's Department of Sanitary Sewer Services in calendar year 2017, in a total aggregate amount less than \$50,000.00; and

WHEREAS, the Executive anticipates making additional purchases from REXEL during calendar year 2017 and requests that she be authorized to make purchases from REXEL, as a Best Practical Source, for operations within the Executive's Department of Sanitary Sewer Services in calendar year 2017, in a total aggregate amount not to exceed \$100,000.00; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize purchases by the Executive from REXEL, as a Best Practical Source, for operations within the Executive's Department of Sanitary Sewer Services in calendar year 2017, in a total aggregate amount not to exceed \$100,000.00;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

This Council hereby authorizes purchases by the County Executive from REXEL. as a Best Practical Source, for operations within the Executive's Department of Sanitary Sewer Services in calendar year 2017, in a total aggregate amount not to exceed \$100,000.00.

## SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately authorize necessary purchases for operations within the Executive's Department of Sanitary Sewer Services in calendar year 2017.
