7 **A Resolution increasing appropriations, in the amount of \$10,000.00, in the Juvenile**
8 **Court's Federal Fiscal Year 2017 Temporary Assistance for Needy Families grant for the**
9 **Juvenile Court's Reentry Program, for Court of Common Pleas-Juvenile Division, and**
10 **declaring an emergency.**

12 WHEREAS, County Council previously adopted Resolution No. 2016-348, which
13 authorized the County Executive to execute any documents necessary to accept an award from
14 the County Executive's Department of Job and Family Services of a Federal Fiscal Year ("FFY")
15 2017 Temporary Assistance to Needy Families ("TANF") grant to the Court of Common Pleas-
16 Juvenile Division for Jobs Reentry Program services, for the period 10/1/16 through 9/30/17, in
17 the amount of \$115,000.00, with no local cash match requirement, and appropriated said grant
18 funds; and

20 WHEREAS, the actual costs of the Reentry Program are \$125,000.00; and

22 WHEREAS, the Juvenile Division wishes to use Helping Ohioans Move, Expanding
23 Choice grant funds to make up for the \$10,000.00 shortfall; and

25 WHEREAS this Council finds and determines, after reviewing all pertinent information,
26 that increasing appropriations, in the amount of \$10,000.00, in the FFY 2017 TANF grant for the
27 Reentry Program is necessary and in the best interest of the County of Summit;
