7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Greenleaf Family Center to provide case management services to assist two-**  
9 **parent assistance groups and Summit County Occupational Preparation Experience**  
10 **participants, for a one-year term, from 10/1/17 through 9/30/18, in an amount not to exceed**  
11 **\$133,110.00, for the Executive's Department of Job and Family Services, and declaring an**  
12 **emergency.**

14 WHEREAS, the Board of Control, at its meeting held August 16, 2017, awarded a  
15 professional service contract with Greenleaf Family Center to provide case management services  
16 for two-parent assistance groups and Summit County Occupational Preparation Experience  
17 participants in meeting Ohio Works First work participation requirements, from 10/1/17 through  
18 9/30/18, in an amount not to exceed \$133,110.00, subject to confirmation by County Council;

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
22 that the aforementioned professional service contract with Greenleaf Family Center is necessary  
23 and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The award by the Board of Control of a professional service contract with Greenleaf  
31 Family Center to provide case management services for two-parent assistance groups and  
32 Summit County Occupational Preparation Experience ("SCOPE") participants in meeting Ohio  
33 Works First ("OWF") work participation requirements, for a one-year term, from 10/1/17  
34 through 9/30/18, in an amount not to exceed \$133,110.00, is hereby confirmed and the County  
35 Executive is hereby authorized to execute such professional service contract.

39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the citizens of the County of Summit, and for the further reason to immediately  
41 provide for assistance to two-parent households and SCOPE participants in meeting mandated  
42 OWF work participation requirements effective 10/1/17.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
