7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Quality Control Inspection, Inc., as a Best Practical Source, for construction**
9 **inspection services, for a one-year term, with two options to renew for an additional one-**
10 **year term, in an amount not to exceed \$90,000.00, for the Engineer, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 6, 2017, awarded a
14 professional service contract with Quality Control Inspection, Inc., as a Best Practical Source, for
15 construction inspection services, for a one-year term, with two options to renew for a one-year
16 term, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned professional service contract with Quality Control Inspection, Inc., is
20 necessary and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that:

27 The award by the Board of Control of a professional service contract with Quality
28 Control Inspection, Inc., as a Best Practical Source, for construction inspection services, for a
29 one-year term, with two options to renew for a one-year period, in an amount not to exceed
30 \$90,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
31 professional service contract.

33 SECTION 2

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further reason to immediately
37 provide for necessary construction inspection services for the County Engineer's Office.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,

51 121.22 of the Ohio Revised Code.
