Crosier St, Akron, Ohio 44311, in Council District 4, for an estimated cost not to exceed \$121,000.00, for the Executive's Department of Administrative Services-Physical Plants Division, and declaring an emergency.

WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires this Council's authorization for the County Executive to advertise for bids; and

WHEREAS, the County Executive wishes to advertise for bids for the Summit County Jail Sanitary Sewer Grinder Project, to obtain a grinder for two sewer laterals to shred trash before it enters the main sewer line at the Summit County Jail, located at 205 E. Crosier St, Akron, Ohio 44311, in Council District 4, for an estimated cost not to exceed \$121,000.00; and

WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office; and

WHEREAS this Council finds and determines, after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to advertise for bids for the Summit County Jail Sanitary Grinder Project, to obtain a grinder for two sewer laterals to shred trash before it enters the main sewer line at the Summit County Jail;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The County Executive is authorized to advertise for bids for the Summit County Jail Sanitary Grinder Project, to obtain a grinder for two sewer laterals to shred trash before it enters the main sewer line at the Summit County Jail, located at 205 E. Crosier St, Akron, Ohio 44311, in Council District 4, for an estimated cost not to exceed \$121,000.00.

## SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason that it authorizes the Executive to immediately advertise for bids for a necessary grinder for two sewer laterals to shred trash before it enters the main sewer line at the Summit County Jail to prevent trash from causing sanitary backups at the Jail.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
