7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept the award from the State of Ohio Department of Rehabilitation and Correction,**
9 **through the Targeted Community Alternatives to Prison grant program for State Fiscal**
10 **Years 2018 and 2019, for a total amount of \$2,970,663.00, with no local cash match**
11 **requirement for the period 10/9/17 through 6/30/19 for the Executive's Department of Law,**
12 **Insurance and Risk Management – Division of Public Safety, and declaring an emergency.**
13

14 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (ODRC) has
15 created the Targeted Community Alternatives to Prison (TCAP) grant program to provide
16 funding to local communities as a result of changes in the Ohio Revised Code, which will
17 prohibit some fifth degree felony offenders from serving a prison sentence in an Ohio prison on
18 or after July 1, 2018; and

20 WHEREAS, ODRC has identified Summit County as a target county, which provides
21 Summit County the opportunity to voluntarily participate in the State Fiscal Year (SFY) 2018
22 TCAP program and requires participation in SFY 2019; and
23

24 WHEREAS, the Summit County Executive, Summit County Sheriff and Administrative
25 Judge of the Court of Common Pleas, have agreed on a plan to use this funding to enhance
26 programming and supervision alternatives to be able to maintain the TCAP population locally;
27

28 WHEREAS, ODRC has awarded to the County of Summit a TCAP grant for SFY 2018,
29 in the amount of \$1,336,798.00, with no local cash match requirement for the period 10/9/17
30 through 6/30/18; and

32 WHEREAS, ODRC has awarded to the County of Summit a TCAP grant for SFY 2019,
33 in the amount of \$1,633,865.00, with no local cash match requirement for the period 7/1/18
34 through 6/30/19; and

36 WHEREAS, it is necessary for the County Executive to execute documents necessary to
37 accept the grant award; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
41 execute any documents necessary to accept the SFY 2018 and 2019 TCAP grant funds in a total
42 amount of \$2,970,663.00, with no local cash match requirement;

44 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
45 of Ohio, that:

49 The County Executive is authorized to accept the award from the State of Ohio
50 Department of Rehabilitation and Correction, through the Targeted Community Alternatives to
51 Prison grant program for State Fiscal Years 2018 and 2019, for a total amount of \$2,970,663.00,
52 with no local cash match requirement for the period 10/9/17 through 6/30/19.
