7 **A Resolution increasing appropriations, in the amount of \$2,713,596.24, in the Juvenile**
8 **Court's Federal Fiscal Year 2018 RECLAIM grant, for Court of Common Pleas-Juvenile**
9 **Division, and declaring an emergency.**

11 WHEREAS, County Council previously adopted Resolution No. 2017-227, which
12 authorized the County Executive to execute any documents necessary to accept an award from
13 the Ohio Department of Youth Services of a State Fiscal Year 2018 RECLAIM Ohio grant to the
14 Court of Common Pleas-Juvenile Division for its Youth Services Grant line, for the period of
15 7/1/17 to 6/30/18, in the amount of \$3,759,339.19, with no local cash match requirement, and
16 appropriated said grant funds; and

18 WHEREAS, the final allocation for the RECLAIM program is \$6,472,935.43; and

20 WHEREAS, the Juvenile Court wishes to appropriate an additional \$2,713.596.24 in
21 grant funding from the Ohio Department of Youth Services; and

23 WHEREAS this Council finds and determines, after reviewing all pertinent information,
24 that increasing appropriations, in the amount of \$2,713,596.24, in the State Fiscal Year 2018
25 RECLAIM Ohio grant for the Youth Services Grant allocation is necessary and in the best
26 interest of the County of Summit;
