7 **A Resolution deleting from the County’s Classification and Compensation Plan the**
8 **classification, classification specification and salary schedule for the non-bargaining**
9 **classified positions of GIS Technician #28213 and GIS Supervisor #28214 at the County**
10 **Executive’s Department of Community and Economic Development, for the Executive’s**
11 **Department of Human Resources, and declaring an emergency.**

13 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
14 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
15 Codified Ordinances of the County of Summit to establish classifications, classification
16 specifications and pay/salary schedules for all County employees; and

17
18 WHEREAS, the non-bargaining classified positions of GIS Technician #28213 and GIS
19 Supervisor #28214 at the County Executive’s Department of Community and Economic
20 Development are no longer needed in the aforementioned department due to the changing nature
21 of the GIS field; and

23 WHEREAS, the primary functions of these classifications have been included in the job
24 functions of higher classifications in the series; and

26 WHEREAS, the Executive has requested, pursuant to Section 169.99 of the Codified
27 Ordinances of the County of Summit, that the Human Resource Commission (“HRC”) approve
28 the deletion of the positions of GIS Technician #28213 and GIS Supervisor #28214 from the
29 County’s Classification and Compensation Plan; and

31 WHEREAS, the HRC, at its September 21, 2017 meeting, approved the deletion of the
32 positions of GIS Technician #28213 and GIS Supervisor #28214 from the County’s
33 Classification and Compensation Plan, as set forth in HRC Order No. 17-02, attached to this
34 Resolution as Exhibit A; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County of Summit to delete from the County’s
38 Classification and Compensation Plan the classification, classification specification and salary
39 schedule for the non-bargaining classified positions of GIS Technician #28213 and GIS
40 Supervisor #28214 for the aforementioned reason;

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens and employees of the County of Summit, and for the further reason that it is necessary in order to immediately delete the positions from the County's Classification and Compensation Plan.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
