A Resolution confirming an award by the Board of Control of a professional service contract with Guardian Life Insurance Company to provide voluntary dental care benefits for County employees, for a one-year term, from 1/1/18 through 12/31/18, with two options to renew for an additional one-year term, in an amount not to exceed a single rate of \$27.37 per month, and a family rate of \$81.11 per month for either the PPO or the Value Plan, for an estimated total amount not to exceed \$1,431,285.00, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, on behalf of the County of Summit, the County's consultant, NFP Corporate Services (OH), Inc., prepared and sent a request for proposals to vendors to provide voluntary dental care benefits for County employees and the County has selected Guardian Life Insurance Company as being the most responsive and responsible vendor; and

WHEREAS, the Board of Control, at its meeting held October 25, 2017, awarded a professional service contract with Guardian Life Insurance Company to provide voluntary dental care benefits for County employees, for a one-year term, from 1/1/18 through 12/31/18, with two options to renew for an additional one-year term, in an amount not to exceed a single rate of \$27.37 per month, and a family rate of \$81.11 per month for either the PPO or the Value Plan, for an estimated total amount not to exceed \$1,431,285.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Guardian Life Insurance Company is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a professional service contract with Guardian Life Insurance Company to provide voluntary dental care benefits for County employees, for a one-year term, from 1/1/18 through 12/31/18, with two options to renew for an additional one-year term, in an amount not to exceed a single rate of \$27.37 per month, and a family rate of \$81.11 per month for either the PPO or the Value Plan, for an estimated total amount not to exceed \$1,431,285.00, is hereby confirmed and the County Executive is hereby authorized to execute such professional service contract.

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further purpose to immediately approve a necessary contract to provide voluntary dental care benefits for County employees effective 1/1/18.
