7 **A Resolution assessing the parcels of Heritage Centre Allotment Replat for drainage**
8 **maintenance, in Copley Township, in Council District 5, for the Engineer, and declaring an**
9 **emergency.**

11 WHEREAS, by Resolution No. 2017-458, this Council will be approving and accepting
12 the Heritage Centre Allotment Replat, located in Copley Township, in Council District 5; and

13
14 WHEREAS, said plat includes a drainage maintenance assessment provision signed by
15 all owners of parcels located within said subdivision, with said provision applying to subsequent
16 owners of the same parcels; and

17
18 WHEREAS, assessments for drainage maintenance also are permitted by Sections
19 6137.02 and 6137.03 of the Ohio Revised Code; and;

20
21 WHEREAS, the County Engineer seeks to assess for drainage maintenance for said
22 subdivision and to fully execute his powers and duties thereof; and

23
24 WHEREAS, the Engineer has prepared a special assessment worksheet, attached to this
25 Resolution as Exhibit A, which apportions necessary charges for drainage maintenance among
26 the subdivision's benefited parcel owners; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County of Summit to assess the parcels of
30 Heritage Centre Allotment Replat, in Copley Township, in Council District 5, for drainage
31 maintenance, as set forth in Exhibit A attached to this Resolution;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that;

36 SECTION 1

38 A drainage maintenance fund for Heritage Centre Allotment Replat, located in Copley
39 Township, Council District 5, is hereby established.

41 SECTION 2

43 Owners of parcels within Heritage Centre Allotment Replat shall be assessed for drainage
44 maintenance per the special assessment worksheet attached as Exhibit A. Each assessment is
45 proportional to the estimated benefit to the respective parcel.

47 SECTION 3

49 Pursuant to Section 6137.03 of the Ohio Revised Code, the Clerk of Council shall certify
50 the attached assessments to the County Fiscal Officer for placement on the next succeeding tax
51 duplicate to be collected and paid.
