7 **A Resolution appropriating \$5,000.00 received from State Farm Insurance and Summa for**  
8 **a Safe Communities Coalition Program Fund, for use through 12/31/2017, for the Sheriff,**  
9 **and declaring an emergency.**

10  
11 WHEREAS, this Council previously adopted Resolution No. 2017-422, which authorizes  
12 the County Executive to execute any documents necessary to accept an award of a Safe  
13 Communities grant, from the Ohio Department of Public Safety in the amount of \$85,000.00,  
14 with no local cash match requirement, for the period 10/1/17 to 9/30/18 and appropriates the  
15 grant funds, for the period 10/1/17 through 12/31/17;

16  
17 WHEREAS, State Farm Insurance and Summa have each issued payments in the amount  
18 of \$2,500.00 to the County of Sheriff's Office as donations for a Safe Communities Coalition  
19 Program Fund; and

20  
21 WHEREAS, the Sheriff's Office intends to use the \$5,000.00 in donations for supplies  
22 and other expenses related to a Safe Communities Program Fund; and

23  
24 WHEREAS, because said donations may not be placed in the Safe Communities fund  
25 established for the grant from the Ohio Department of Public Safety by Resolution No. 2017-  
26 422, it is necessary to establish a new Safe Communities Coalition Program Fund; and

28 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
29 necessary and in the best interest of the County of Summit to appropriate the aforementioned  
30 donated funds, in the amount of \$5,000.00, into a Safe Communities Coalition Program Fund;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
