An Ordinance amending Chapter 113 of the Codified Ordinances of the County of Summit, entitled "Miscellaneous Fees" to add Section 113.14, entitled "Parking Deck Fees," for the Executive's Department of Administrative Services, and declaring an emergency.

WHEREAS, the County Executive has reviewed the current Summit County Parking Deck fees and compared them to parking decks of other Ohio public entities and has concluded that the current fees no longer reflect the actual cost of parking deck maintenance, including equipment, materials, supplies and personnel costs; and

WHEREAS, the County Executive has proposed increasing the fees for parking in the Summit County Parking Deck; and

WHEREAS, in order to increase the Summit County Parking Deck fees, it is necessary that Chapter 113 of the Codified Ordinances of the County of Summit entitled "Miscellaneous Fees" be amended to add Section 113.14, entitled "Parking Deck Fees; and

WHEREAS, this Council finds and determines that it is necessary and in the best interest of the County of Summit to enact section 113.14 to establish a fee schedule for the Summit County Parking Decks.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Chapter 113 of the Codified Ordinances of the County of Summit, entitled "Miscellaneous Fees," is hereby amended to add Section 113.14, entitled "Parking Deck Fees," as follows:

SECTION 2

This Ordinance is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason of immediately providing for fees to compensate the County for utilization of the Summit County Parking Deck.
