A Resolution authorizing the County Executive to execute a renewal (first of two) of a three-year policing contract the with Akron-Canton Regional Airport Authority Board, in Council District 8, for a term from 1/1/18 through 12/31/20, for a total amount of \$3,162,286.21, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2015-008, which authorized the County Executive a three-year policing contract with the Akron-Canton Regional Airport Authority Board (the "Akron-Canton Airport"), in Council District 8, pursuant to which the County Sheriff will provide the Akron-Canton Airport with 19,820.98 deputy/sergeant hours, for the period of 1/1/15 through 12/31/17, with two options to renew for an additional two-year term, in exchange for payment by Regional Airport of a total gross amount of \$3,674,376.20, less a contingent credit, during the three-year term of the contract.; and

WHEREAS, the Akron-Canton Airport has requested that the County of Summit enter into a renewal (first of two) of the policing contract pursuant to which the Sheriff will provide 15,421.20 deputy/sergeant hours, for the period 1/1/18 through 12/31/20, and

WHEREAS, the Akron-Canton Airport has agreed to pay the County \$964,726.54 for the first year, \$1,052,096.35 for the second year and \$1,145,463.32 for the third year, for a total amount of \$3,162,286.21 during the three-year term of the contract; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information. that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned renewal (first of two) of the policing contract with the Akron-Canton Airport;
