7 **A Resolution confirming an award by the Board of Control of a IV-D intergovernmental**  
8 **agreement with the County Sheriff for security and processing services, for a one-year**  
9 **term, from 1/1/18 through 12/31/18, in an amount not to exceed \$750,000.00, for the**  
10 **Prosecutor-Child Support Enforcement Agency, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting on February 7, 2018, awarded a IV-D  
13 intergovernmental agreement with the County Sheriff for security and process serving for the  
14 County Prosecutor's Child Support Enforcement Agency, for a one-year term, from 1/1/18  
15 through 12/31/18, in an amount not to exceed \$750,000.00; and

17 WHEREAS, this Council finds and determines after reviewing all pertinent information,  
18 that the aforementioned IV-D intergovernmental agreement with the County Sheriff is necessary  
19 and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
22 of Ohio, that;

26 The award by the Board of Control of a IV-D intergovernmental agreement with the  
27 County Sheriff for security and processing services for the County Prosecutor's Child Support  
28 Enforcement Agency, for a one-year term, from 1/1/18 through 12/31/18, in an amount not to  
29 exceed \$750,000.00 is hereby confirmed and the County Executive is hereby authorized to  
30 execute such intergovernmental agreement.

34 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
35 welfare of the citizens of the County of Summit and for the further purpose of immediately  
36 providing necessary security and processing services for the Prosecutor's Child Support  
37 Enforcement Agency effective 1/1/18.

42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take


