7 **A Resolution authorizing the County Executive to advertise for bids for payroll services for**
8 **youth employment programs, for an estimated total cost not to exceed \$2,225,000.00, for**
9 **the Executive's Department of Job and Family Services, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Executive to advertise for bids; and

13
14 WHEREAS, the Department of Job and Family Services is in need of a vendor to provide
15 payroll services for various youth employment programs, including summer youth and year
16 round programs; and

17
18 WHEREAS, the State of Ohio recognizes the method of having one payroll service
19 provider is a cost effective manner to handle issuance of pay and workers' compensation
20 liability, which alleviates the burden of meeting payroll and carrying workers' compensation for
21 non-profits and employer sites for the temporary employees; and

22
23 WHEREAS, the Department of Job and Family Services projects the cost to not exceed
24 \$2,225,000.00, which includes youth payroll, corresponding payroll taxes, and payroll service
25 costs, utilizing Workforce Investment and Opportunity Act ("WIOA") and Temporary
26 Assistance for Needy Families ("TANF") funding sources; and

28 WHEREAS, services will be provided for the period 5/1/18 through 6/30/19, with three
29 annual renew options; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
33 advertise for bids for payroll services for youth employment programs, for an estimated total cost
34 not to exceed \$2,225,000.00;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

41 The County Executive is hereby authorized to advertise for bids for payroll services for
42 youth employment programs, for an estimated total cost not to exceed \$2,225,000.00.

46 This Resolution is hereby declared an emergency in the interest of the health, safety, and
47 welfare of the citizens of the County of Summit, and for the further reason to immediately
48 authorize the County Executive to advertise for bid for payroll services for youth employment


