7 **A Resolution authorizing the County Executive to advertise for bids for incentive issuance**
8 **services for employment programs, for an estimated total cost not to exceed \$450,000.00,**
9 **for the Executive's Department of Job and Family Services, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Engineer to advertise for bids; and

13
14 WHEREAS, the Department of Job and Family Services is in need of a vendor to provide
15 monetary incentive payment services for various employment program participants including,
16 but not limited to, Ohio Work Incentive Program ("OWIP") and Comprehensive Case
17 Management Employment Program ("CCMEP") participants; and

19 WHEREAS, the vendor will serve as payroll agent, but not employer of record, and will
20 issue 1099s for incentive amounts, withholdings not to be deducted from incentive payments;
21 and

23 WHEREAS, the Department of Job and Family Services projects the cost to not exceed
24 \$450,000, which includes incentives and incentive issuance service costs, utilizing Workforce
25 Investment and Opportunity Act ("WIOA") and Temporary Assistance for Needy Families
26 ("TANF") funding sources; and

28 WHEREAS, services will be provided for the period 5/1/18 through 6/30/19, with three
29 annual renew options; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
33 advertise for bids for the incentive issuance services, for an estimated total cost not to exceed
34 \$450,000.00;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

41 The County Executive is hereby authorized to advertise for bids for incentive issuance
42 services for employment programs, for an estimated total cost not to exceed \$450,000.00.

46 This Resolution is hereby declared an emergency in the interest of the health, safety, and
47 welfare of the citizens of the County of Summit, and for the further reason to immediately
48 authorize the County Executive to advertise for bid for necessary incentive issuance services for
49 employment programs.




