7 **A Resolution authorizing the County Executive to advertise for bids for a roof replacement**  
8 **project at the Juvenile Court Building, for an estimated total cost not to exceed**  
9 **\$100,200.00, for the Executive's Department of Administrative Services-Physical Plants**  
10 **Division, and declaring an emergency.**

11  
12 WHEREAS, the existing roof at the Juvenile Court Building leaks significantly, and the  
13 warranty coverage period has ended; and

14  
15 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
16 requires this Council's authorization for the County Executive to advertise for bids; and

17  
18 WHEREAS, the County Executive wishes to advertise for bids for the roof replacement  
19 project at the Juvenile Court Building, for an estimated total cost not to exceed \$100,200.00; and

20  
21 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

24 WHEREAS this Council finds and determines, after reviewing all pertinent information  
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 advertise for bids for the aforementioned project;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 The County Executive is authorized to advertise for bids for the roof replacement project  
34 at the Juvenile Court Building, for an estimated total cost not to exceed \$100,200.00.

36 SECTION 2

38 This Resolution is hereby declared an emergency in the interest of the health, safety and  
39 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the  
40 Executive to immediately advertise for bids for the aforementioned roof replacement project at  
41 the Juvenile Court Building, in order to prolong the service life of the County facility.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.




