14 WHEREAS, the Board of Control, at its meeting held March 14, 2018 awarded a
15 professional service contract with Tri-County Jobs for Ohio's Graduates for 2018 Summer Youth
16 Employment Program outreach and eligibility services, for the period of 4/1/18 through 6/30/18
17 in the amount of \$75,000.00 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that a professional service contract with Tri-County Jobs is necessary and in the best interest of
21 the County of Summit;

30 4/1/18 through 6/30/18 in the amount of \$75,000.00, is hereby confirmed and the County
31 Executive is hereby authorized to execute such professional services contract.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of Summit County, and for the further reason to immediately approve the
37 necessary professional service contract to provide outreach and eligibility determination services.

42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.
