7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
8 **with the Summit County Combined General Health District, and the County of Summit**
9 **Alcohol, Drug Addiction and Mental Health Services Board, for the purchase and use of**
10 **the Forensic Advantage Integrated Case Management System, for the Executive's**
11 **Department of Medical Examiner, and declaring an emergency.**

13 WHEREAS, the County has determined that there is need for its Medical Examiner to
14 have an updated and fully integrated case management system; and

15
16 WHEREAS, the Summit County Combined General Health District dba Summit County
17 Public Health ("SCPH") and the County of Summit Alcohol, Drug Addiction and Mental Health
18 Services Board ("ADM Board") have certain reporting requirements to the State of Ohio that
19 would be more efficiently completed by use of data and reports from the Medical Examiner's
20 system; and

22 WHEREAS, the County intends to acquire the Forensic Advantage Integrated Case
23 Management System ("System") for the Medical Examiner, and to provide SCPH and ADM
24 Board access to the data collected in the System in exchange for SCPD and ADM Board
25 contributing towards the purchase of the System pursuant to the terms and conditions of the
26 Agreement, attached hereto as Exhibit A; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that it is necessary and in the best interest of the County to authorize the Executive to execute the
30 aforementioned intergovernmental agreement with the Summit County Combined General
31 Health District, and the County of Summit Alcohol, Drug Addiction and Mental Health Services
32 Board;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The County Executive is hereby authorized to execute an intergovernmental agreement
40 with Summit County Combined General Health District dba Summit County Public Health, and
41 the County of Summit Alcohol, Drug Addiction and Mental Health Services Board, for the
42 purchase and use of the Forensic Advantage Integrated Case Management System.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit, and for the further purpose to immediately
48 authorize the County to enter into the agreement and allow for the case management system to
49 become readily available.




