7 **A Resolution authorizing the County Executive to execute any documents necessary to accept**
8 **the award of a Federal Fiscal Year 2018 Victims of Crime Act training grant from the State of**
9 **Ohio Attorney General’s Office, for the period of 5/13/18 through 5/15/18, in the amount of**
10 **\$1,381.60, with a local cash match requirement of \$345.40, and appropriating said grant funds,**
11 **for the Court of Common Pleas - Juvenile Division, and declaring an emergency.**

13 WHEREAS, the County of Summit, Court of Common Pleas - Juvenile Division has received
14 an award from the State of Ohio Attorney General’s Office of a Federal Fiscal Year (“FFY”) 2018
15 Victims of Crime Act (“VOCA”) grant for the period 5/13/18 through 5/15/18, in the amount of
16 \$1,381.60, with a local cash match requirement of \$345.40, for a VOCA award total of \$1,727.00;

19 WHEREAS, the local match requirement will be provided by the Court of Common Pleas-
20 Juvenile Division’s General Fund; and

22 WHEREAS, the grant funds allow two juvenile employees to attend the 2018 two-day
23 Victims Assistance conference in Columbus, Ohio, in May 2018; and

25 WHEREAS, it is necessary to authorize the County Executive to execute any documents
26 necessary to accept the aforementioned grant from the State of Ohio Attorney General’s Office and
27 to appropriate said grant funds;

37 \$1,381.60, with a local cash match requirement of \$345.40.
