7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **MTech Company, for one Dyna-Vac Tank Truck, under State Term Pricing, in an amount**
9 **not to exceed \$184,790.00, for the Executive's Department of Sanitary Sewer Services, and**

12 WHEREAS, the Board of Control, at its April 4, 2018 meeting, awarded a purchase
13 contract with MTech Company, for one Dyna-Vac Tank Truck ("Truck"), under State Term
14 Pricing, in an amount not to exceed \$184,790.00; and

16 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
17 that the purchase contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a purchase contract with MTech Company for one
25 Dyna-Vac Tank Truck ("Truck"), under State Term Pricing, in an amount not to exceed
26 \$184,790.00, is hereby confirmed, and the County Executive is hereby authorized to execute
27 such purchase contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the Department of Sanitary Sewer Services with the Truck to continue servicing its
34 customers.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of the Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,
