7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Rolta AdvizeX Technologies, LLC, as a Best Practical Source, for network**
9 **and data center infrastructure support, for a one-year term, in an amount not to exceed**
10 **\$6,400.00, for the Office of Information Technology, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held April 11, 2018, awarded a
13 professional service contract to Rolta AdvizeX Technologies, LLC, as a Best Practical Source,
14 for network and data center infrastructure support, approved by the IT Board on 4/5/18, for a
15 one-year term, in an amount not to exceed \$6,400.00, subject to confirmation by County
16 Council; and

18 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
19 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar
20 year, where no additional competitive quotes or bids have been taken, shall be made only upon
21 authorization of County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned professional service contract with Rolta AdvizeX Technologies, LLC, is
25 necessary and in the best interest of the County of Summit;

27 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
28 of Ohio, that:

32 The award by the Board of Control of a professional service contract with Rolta AdvizeX
33 Technologies, LLC, as a Best Practical Source, for network and data center infrastructure
34 support, approved by the IT Board on 4/5/18, for a one-year term, in an amount not to exceed
35 \$6,400.00, is hereby confirmed and the County Executive is hereby authorized to execute such
36 professional service contract.

40 This Resolution is hereby declared an emergency in the interest of health, safety and
41 welfare of the citizens of the County of Summit, and for the further reason to immediately
42 provide for necessary support services needed by the Office of Information Technology.

47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
