12 WHEREAS, the Board of Control, at its meeting held April 25, 2018, awarded a
13 professional service contract to MS Consultants, Inc., for design services for the Wright Road
14 Bridge Replacement project, in an amount not to exceed \$189,858.00, subject to confirmation by
15 County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned professional service contract with MS Consultants, Inc., is necessary and
19 in the best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with MS
27 Consultants, Inc., for design services for the Wright Road Bridge Replacement project, in an
28 amount not to exceed \$189,858.00, is hereby confirmed and the County Executive is hereby
29 authorized to execute such professional service contract.

33 This Resolution is hereby declared an emergency in the interest of health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 confirm the award of a professional service contract with MS Consultants, Inc., to begin the
36 design process for necessary improvements to the Wright Road Bridge.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
