7 **A Resolution authorizing the County Executive's Department of Job and Family Services**  
8 **to make expenditures, in an amount not to exceed \$5,000.00, for hospitality items incurred**  
9 **in providing training sessions to be held in 2018, for the Executive's Department of Job and**  
10 **Family Services, and declaring an emergency.**

11  
12 WHEREAS, the County Executive's Department of Job and Family Services conducts  
13 training, including worksite conferences, for the County of Summit; and

14  
15 WHEREAS, such training sessions are attended by County employees, outside  
16 organization and elected officials; and

17  
18 WHEREAS, the Executive's Department of Job and Family Services wishes to pay  
19 hospitality expenses in an amount not to exceed \$5,000.00 in 2018 related to the aforementioned  
20 training sessions; and

21  
22 WHEREAS, the Office of the Attorney General of the State of Ohio issued Opinion No.  
23 82-006, which authorizes the expenditure of funds by a local political subdivision for its  
24 employees as long as those expenditures are necessary to further a public purpose and if the  
25 political subdivision's determination to make such expenditures is not manifestly arbitrary or  
26 unreasonable; and

28 WHEREAS, Sections 177.24 (b) and (c) of the Codified Ordinances of the County of  
29 Summit require the approval of County Council for hospitality expenditures exceeding \$2,000.00  
30 per year and for hospitality expenditures for purposes other than employee training, meetings,  
31 and organization strategic planning meetings; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
34 that it is necessary and in the best interest of the County of Summit to authorize the Executive's  
35 Department of Job and Family Services to make expenditures, in an amount not to exceed  
36 \$5,000.00, for hospitality items incurred in providing training sessions to be held in 2018 and  
37 that such expenditures are for a valid public purpose;

39 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
40 of Ohio, that:

44 The County Executive's Department of Job and Family Services is hereby authorized to  
45 make expenditures, in an amount not to exceed \$5,000.00, for hospitality items incurred in  
46 providing training sessions to be held in 2018. County Council hereby finds and determines that  
47 such expenditures are for a valid public purpose.

7 welfare of the residents of the County of Summit and for the further reason of immediately  
8 authorizing the Executive's Department of Job and Family Services to make expenditures for  
9 hospitality items incurred in providing training sessions to be held in 2018.

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
15 effect and be in force at the earliest time provided by law.
