7 **A Resolution authorizing the County Executive to execute a renewal (first of two) of a One-**
8 **Stop Operator Services contract with the Summit and Medina Workforce Area Council of**
9 **Governments, pursuant to which the Executive's Department of Job and Family Services**
10 **will provide One-Stop Operator services at the Ohio Means Jobs Summit County Center,**
11 **for the period 7/1/18 to 6/30/19, for which the County shall be paid an amount not to exceed**
12 **\$219,569.19, for the Executive's Department of Job and Family Services, and declaring an**
13 **emergency.**

14
15 WHEREAS, the U.S. Department of Labor's Employment and Training Administration
16 funds a network of American Job Centers ("AJCs") to provide free employment assistance to job
17 seekers at AJC network locations across the United States; and

18
19 WHEREAS, pursuant to the requirements of Workforce Innovation and Opportunity Act
20 of 2014 (the "WIOA") Section 121(d)(2)(A), Local Workforce Areas must competitively procure
21 the Operators of AJCs; and

22
23 WHEREAS, pursuant to requirements of WIOA, and on the behalf of the
24 Summit/Medina Workforce Development Board (the "WDB"), the Summit and Medina
25 Workforce Area Council of Governments (the "SAMWA COG"), which serves as the Ohio
26 Workforce Area 2 ("Area 2") staff, completed a competitive process to procure Operators for the
27 Area's AJCs, known in the State of Ohio as Ohio Means Jobs Centers-in Summit County as the
28 Ohio Means Jobs Summit County Center, and in Medina County as the OMJ Medina County
29 Center; and

31 WHEREAS, on behalf of the WDB, the SAMWA COG awarded a One-Stop Operator
32 Services contract to the County Executive's Department of Job and Family Services ("DJFS") to
33 provide One-Stop Operator Services at the Ohio Means Jobs Summit County Center through
34 6/30/18, with two options to renew for an additional one-year term, and this Council
35 subsequently authorized the County Executive to execute the same pursuant to Resolution No.
36 2017-347; and

38 WHEREAS, the County Executive has recommended that the County enter into a
39 renewal (first of two) of the One-Stop Operator Services contract with the SAMWA COG,
40 pursuant to which DJFS will provide One-Stop Operator Services at the Ohio Means Jobs
41 Summit County Center, for the period 7/1/18 to 6/30/19, for which the County shall be paid an
42 amount not to exceed \$219,569.19; and

43
44 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
45 that it is necessary and in the best interest of the County of Summit to authorize the County
46 Executive to execute a renewal (first of two) of the One-Stop Operator Services contract with the
47 SAMWA COG, pursuant to which DJFS will provide One-Stop Operator services at the Ohio
48 Means Jobs Summit County Center, for the period 7/1/18 to 6/30/19, for which the County shall
49 be paid an amount not to exceed \$219,569.19; and

51 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

4 SECTION 1

5
6 The County Executive is hereby authorized to execute a renewal (first of two) of a One-
7 Stop Operator Services contract with the Summit and Medina Workforce Area Council of
8 Governments ("SAMWA COG"), pursuant to which the Executive's Department of Job and
9 Family Services ("DJFS") will provide One-Stop Operator services at the Ohio Means Jobs
10 Summit County Center, for the period 7/1/18 to 6/30/19, for which the County shall be paid an
11 amount not to exceed \$219,569.19.

13 SECTION 2

14
15 This Resolution is hereby declared an emergency in the interest of the health, safety and
16 welfare of the residents of the County of Summit, and for the further reason to immediately
17 authorize the Executive to execute a necessary One-Stop Operator Services contract with the
18 SAMWA COG, so that DJFS may immediately provide said services at the Ohio Means Jobs
19 Summit County Center.

21 SECTION 3

23 Provided this Resolution receives the affirmative vote of eight members, it shall take
24 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
25 effect and be in force at the earliest time provided by law.

29 It is found and determined that all formal actions of this Council concerning and relating
30 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
31 deliberations of this Council and of any of its committees that resulted in such formal action,
32 were in meetings open to the public, in compliance with all legal requirements, including Section
33 121.22 of the Ohio Revised Code.
