7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1032 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO (Clerical and Technical Unit) and the County**
10 **Executive and the County Engineer, for the period 4/1/18 through 3/31/21, for the**
11 **Executive and the Engineer, and declaring an emergency.**

13 WHEREAS, a collective bargaining agreement has been reached between Ohio Council 8
14 and Local 1032 of the American Federation of State, County and Municipal Employees, AFL-
15 CIO (Clerical and Technical Unit) and the County Executive and the County Engineer, for the
16 period 4/1/18 through 3/31/21, which authorizes a three percent (3.0%) increase in pay in each of
17 the three years of the agreement; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
21 execute the aforementioned collective bargaining agreement;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that:

26 SECTION 1

28 The County Executive is hereby authorized to execute a collective bargaining agreement
29 between Ohio Council 8 and Local 1032 of the American Federation of State, County and
30 Municipal Employees, AFL-CIO (Clerical and Technical Unit) and the County Executive and
31 the County Engineer, for the period 4/1/18 through 3/31/21, which authorizes a three percent
32 (3.0%) increase in pay in each of the three years of the agreement.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the residents of the County of Summit and for the further purpose of providing a
38 timely collective bargaining agreement between the Local 1032 Clerical and Technical Unit, and
39 the County Executive and the County Engineer.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.


