7 **A Resolution appropriating 2017 training grant funds from the Public Utilities**
8 **Commission, for the period 9/27/17 through 9/27/18, in the amount of \$8,859.96, with no**
9 **local cash match requirement, for the Executive’s Department of Law, Insurance and Risk**
10 **Management - Division of Public Safety - Emergency Management Agency, and declaring**
11 **an emergency.**

13 WHEREAS, the Public Utilities Commission of Ohio (“PUCO”) previously awarded a
14 PUCO training grant to the Summit County Emergency Management Agency (“SCEMA”), for
15 the period 9/27/17 through 9/27/18, in the amount of \$8,859.96, with no local cash match
16 requirement, to provide for SCEMA Special Operations Response Team (“SORT”) training; and

18 WHEREAS, this Council previously adopted Resolution 2017-468, which authorized the
19 County Executive to accept the grant award from the PUCO; and

21 WHEREAS, it is necessary to appropriate the 2017 training grant funds to provide
22 gasoline cargo tank emergency response training for fire service personnel during the 2018
23 calendar year; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to appropriate the
27 aforementioned training grant funds from the PUCO, in the amount of \$8,859.96; and
