7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Lockhart Concrete Co. for a scour repair project to the Riverview Road Bridge over**
9 **Yellow Creek, in an amount not to exceed \$239,373.80, for the Engineer, and declaring an**
10 **emergency.**

12 WHEREAS, the Board of Control, at its meeting held August 1, 2018, awarded a
13 construction contract with Lockhart Concrete Co. for a scour repair project to the Riverview
14 Road Bridge over Yellow Creek, in an amount not to exceed \$239,373.80, subject to
15 confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned construction contract with Lockhart Concrete Co. is necessary and in the
19 best interest of the County of Summit;

21 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

24 SECTION 1

26 The award by the Board of Control of a construction contract with Lockhart Concrete Co.
27 for a scour repair project to the Riverview Road Bridge over Yellow Creek, in an amount not to
28 exceed \$239,373.80, is hereby confirmed and the County Executive is hereby authorized to
29 execute such construction contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the residents of the County of Summit, and for the further reason to immediately
35 provide for a necessary construction contract for the scour repair project of the Riverview Road
36 Bridge in order for it to proceed as expeditiously as possible.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,
49 were in meetings open to the public, in compliance with all legal requirements, including Section
50 121.22 of the Ohio Revised Code.




