SECTION 2

The Clerk of Council shall set the date of <u>October 1, 2018</u>, at <u>4:30 p.m.</u> for the public hearing on the vacation as required pursuant to Section 5553.05 of the Ohio Revised Code and Section 125.03(e) of the County of Summit Codified Ordinances of the County of Summit, to determine whether the proposed vacation of Oakdale Street as requested by the petition would be for the public convenience or welfare.

SECTION 3

The Clerk of Council shall set the date of October 15, 2018 at 4:30 p.m. for a final hearing on the Petition to vacate the unimproved road right-of-way.

This Resolution is hereby declared to be an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason of timely setting the proper hearing and viewing dates and providing for proper notice of the same without undue delay.

SECTION 7

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 8

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
