8 **A Resolution authorizing the County Executive to execute any documents necessary to**  
9 **accept an award from the Annie E. Casey Foundation of a Juvenile Detention Alternatives**  
10 **Initiative grant, for the period 4/1/18 to 3/31/19, in the amount of \$93,275.00, with no local**  
11 **match requirement, and appropriating said grant funds, for the Court of Common Pleas-**  
12 **Juvenile Division, and declaring an emergency.**

14 WHEREAS, the Annie E. Casey Foundation Juvenile Detention Alternatives Initiative  
15 aims to reduce the unnecessary and inappropriate reliance on local detention centers, save tax  
16 dollars, increase system fairness, and improve the overall juvenile justice system without  
17 compromising public safety; and

19 WHEREAS, the Court of Common Pleas - Juvenile Division has been awarded a Juvenile  
20 Detention Alternatives Initiative (“JDAI”) grant, for the period 4/1/18 to 3/31/19, in the amount  
21 of \$93,275.00, with no local match requirement; and

23 WHEREAS, it is necessary to appropriate said grant funds; and

25 WHEREAS, this Council finds and determines after reviewing all pertinent information  
26 that it is necessary and in the best interest of the County of Summit to authorize the County  
27 Executive to execute any documents necessary to accept the award of the aforementioned JDAI  
28 grant and to appropriate said grant funds;
