7 **A Resolution adjusting existing appropriations, in the amount of \$25,000.00, from the**
8 **Salaries account to the Contract Services account for the Juvenile Court Title IV-E**
9 **Maintenance Fund, for the Court of Common Pleas – Juvenile Division, and declaring an**
10 **emergency.**

12 WHEREAS, County Council previously adopted Resolution 2017-108, which authorized
13 the County Executive to execute a sub-grant agreement with the Ohio Department of Job and
14 Family Services for the receipt of Title IV-E funds by the Court of Common Pleas-Juvenile
15 Division for State Fiscal Years 2018 and 2019, the period from 7/1/17 through 6/30/19, in an
16 amount estimated between \$750,000.00 and \$950,000.00 annually, with no local cash match
17 requirement, for the Court of Common Pleas – Juvenile Division; and

19 WHEREAS, Resolution No. 2017-500 appropriated Title IV-E funds for salaries, benefits
20 and contract services in the Juvenile Court Title IV-E Maintenance Fund; and

22 WHEREAS, it is necessary to adjust existing appropriations in the amount of \$25,000.00,
23 from the Salaries account to the Contract Services account; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned adjustment of appropriations is necessary and in the best interest of the
27 County of Summit;
