7 **A Resolution authorizing the County Executive to execute any documents necessary to accept**  
8 **an award from the Ohio Department of Public Safety, through the Ohio Traffic Safety Office,**  
9 **of a grant for a countywide Operating a Motor Vehicle While Intoxicated Task Force**  
10 **Program, for the period 10/1/18 through 9/30/19, in the amount of \$225,000.01 with no local**  
11 **cash match requirement, confirming an award by the Board of Control of purchase contracts**  
12 **for payments to various law enforcement agencies participating in the Task Force, for services**  
13 **provided, for the period 10/1/18 through 9/30/19, in an amount not to exceed \$142,446.87, and**  
14 **appropriating the said grant funds, for the Sheriff, and declaring an emergency.**

15  
16 WHEREAS, the Ohio Department of Public Safety, through the Ohio Traffic Safety Office,  
17 has awarded the County Sheriff a grant in federal funds for a countywide Operating a Motor Vehicle  
18 While Intoxicated (“OVI”) Task Force Program for the period 10/1/18 through 9/30/19, in the  
19 amount of \$225,000.01 with no local cash match requirement in order to conduct high visibility  
20 enforcement, public awareness, and education for alcohol-related crashes and traffic-related fatalities  
21 in the County of Summit, for the period 10/1/18 through 9/30/19; and

23 WHEREAS, the Board of Control, at its meeting held September 19, 2019, awarded purchase  
24 contracts for payments to various law enforcement agencies for the OVI Task Force services, for the  
25 period 10/1/18 through 9/30/19, subject to confirmation by County Council; and

27 WHEREAS, it is necessary and in the best interest of the County of Summit to appropriate  
28 all said grant funds for the period 10/1/18 through 12/31/18; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information, that  
32 it is necessary and in the best interest of the County of Summit to authorize the County Executive to  
33 execute any documents necessary to accept the aforementioned grant for the OVI Task Force,  
34 confirm the award by the Board of Control of the aforementioned purchase contract and to  
35 appropriate said grant funds;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of

42 The County Executive is hereby authorized to execute any documents necessary to accept a  
43 grant award from the Ohio Department of Public Safety, through the Ohio Traffic Safety Office, for  
44 a countywide Operating a Motor Vehicle While Intoxicated (“OVI”) Task Force Program for the  
45 period 10/1/18 through 9/30/19, in an amount of \$225,000.01 federal funding, with no local cash  
46 match requirement.
