7 **A Resolution authorizing the County Executive to execute any documents necessary to accept**
8 **the award from the County of Summit Alcohol, Drug Addiction & Mental Health Services**
9 **Board of Alcohol Treatment Program Administrative Funds from the Ohio Department of**
10 **Mental Health and Addiction Services for the Turning Point Program in State Fiscal Year**
11 **2019, in the amount of \$14,395.00, with no local cash match requirement, and appropriating**
12 **said grant funds, for the Court of Common Pleas-Adult Probation Department, and declaring**
13 **an emergency.**

15 WHEREAS, the County of Summit Alcohol, Drug Addiction & Mental Health Services
16 Board (“ADM Board”) has awarded the Court of Common Pleas-Adult Probation Department
17 Alcohol Treatment Program Administrative Funds from the Ohio Department of Mental Health and
18 Addiction Services for the Turning Point Program in State Fiscal Year 2019 (“SFY19”), in the
19 amount of \$14,395.00, with no local cash match requirement; and

21 WHEREAS, said Alcohol Treatment Program Administrative Funds will be used to support
22 treatment-related services, including employee salaries and other expenses of the Turning Point
23 Program in SFY19; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is
26 necessary and in the best interest of the County of Summit to authorize the Executive to execute any
27 documents necessary to accept the award of funds from the ADM Board of Alcohol Treatment
28 Program Administrative Funds from the Ohio Department of Mental Health and Addiction Services,
29 and to appropriate said grant funds;

40 \$14,395.00, with no local cash match requirement.


