7 **A Resolution appropriating funds received pursuant to intergovernmental agreements**
8 **with the Cities of Barberton, Cuyahoga Falls, Norton, New Franklin, Stow and Tallmadge**
9 **and Copley Township for direct indictment services provided by the County Prosecutor in**
10 **the Barberton and Stow municipal courts from 1/1/18 through 12/31/18, in the amount of**
11 **\$92,000.00, for the Prosecutor, and declaring an emergency.**

13 WHEREAS, the County and the Cities of Barberton, Cuyahoga Falls Norton, New
14 Franklin, Stow and Tallmadge and Copley Township entered into intergovernmental agreements
15 for direct indictment services to be provided by the County Prosecutor in the Barberton and
16 Stow municipal courts, in exchange for payment by said communities for the term of 1/1/18
17 through 12/31/18 in the amount \$92,000.00; and

19 WHEREAS, it is necessary to appropriate funds received pursuant to said agreements, in
20 the amount of \$92,000.00; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of this County, to appropriate funds received pursuant
24 to the aforementioned agreements with Barberton, Cuyahoga Falls, Norton, New Franklin,
25 Stow, Tallmadge, and Copley Township in the amount of \$92,000.00;
