7 **A Resolution confirming an award by the Board of Control of a IV-D intergovernmental**
8 **agreement with the County Sheriff for the extradition of prisoners involving criminal non-**
9 **support charges, for the period 10/1/18 through 9/30/19, in an amount not to exceed**
10 **\$213,317.25, for the Prosecutor-Child Support Enforcement Agency, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting on October 17, 2018, awarded a IV-D
14 intergovernmental agreement with the County Sheriff for the extradition of prisoners involving
15 criminal non-support charges, for the period 10/1/18 through 9/30/19, in an amount not to exceed
16 \$213,317.25; and

18 WHEREAS, this Council finds and determines after reviewing all pertinent information,
19 that the aforementioned IV-D intergovernmental agreement with the County Sheriff is necessary
20 and in the best interest of the County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
23 of Ohio, that;

27 The award by the Board of Control of a IV-D intergovernmental agreement with the
28 County Sheriff for the extradition of prisoners involving criminal non-support charges, for the
29 period 10/1/18 through 9/30/19, in an amount not to exceed \$213,317.25 is hereby confirmed
30 and the County Executive is hereby authorized to execute such intergovernmental agreement.

34 This Resolution is hereby declared an emergency in the interest of the health, safety, and
35 welfare of the residents of the County of Summit and for the further purpose of immediately
36 providing necessary security and processing services for the Prosecutor's Child Support
37 Enforcement Agency effective 10/1/18.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all


