7 **An amended Resolution authorizing the County Executive to execute, subject to the**  
8 **approval of the Board of Control, a professional service contract with West, a Thomson**  
9 **Reuters Business, as a Best Practical Source, for online legal research services for ~~244~~ 180**  
10 **users, for a three-year term, from 1/1/19 through 12/31/21, in a total amount not to exceed**  
11 **~~\$299,000.00~~ \$308,039.09, for the Executive's Department of Law and Risk Management,**  
12 **and declaring an emergency.**

14 WHEREAS, the County wishes to enter into a professional service contract, approved by  
15 the IT Board on 11/15/18, with West, a Thomson Reuters Business, as a Best Practical Source,  
16 for online legal research services for ~~244~~ 180 users, for a three year term, from 1/1/19 through  
17 12/31/21, in an amount not to exceed ~~\$96,494.52~~ \$99,660.00 annually for the first year;  
18 ~~\$99,839.36~~ \$102,649.80 for the second year; and an annual cost not to exceed ~~\$102,371.04~~  
19 \$105,729.29 for the third year, for a total amount not to exceed ~~\$299,000.00~~ \$308,039.09, for the  
20 three-year term; and

22 WHEREAS, it is necessary to authorize the County Executive to execute, subject to the  
23 approval of the Board of Control, said professional service contract with West, a Thomson  
24 Reuters Business; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
27 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
28 execute, subject to the approval of the Board of Control, the aforementioned professional service  
29 contract with West, a Thomson Reuters Business;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

36 The County Executive is hereby authorized to execute, subject to the approval of the  
37 Board of Control, a professional service contract, approved by the IT Board on 11/15/18, with  
38 West, a Thomson Reuters Business, as a Best Practical Source, for online legal research services  
39 for ~~244~~ 180 users, for a three year term, from 1/1/19 through 12/31/21, not to exceed ~~\$96,494.52~~  
40 \$99,660.00 annually for the first year; ~~\$99,839.36~~ \$102,649.80 for the second year; and an  
41 annual cost not to exceed ~~\$102,371.04~~ \$105,729.29 for the third year, for total amount not to  
42 exceed ~~\$299,000.00~~ \$308,039.09, for the three-year term.
