7 **A Resolution authorizing the County Executive to execute an agreement and any other**
8 **documents necessary for an inter-county transfer of funds between the Executive’s**
9 **Department of Job and Family Services and two local County Department of Job and**
10 **Family Services, pursuant to which agreement Summit County will transfer up to**
11 **\$107,471.94 in exchange for up to \$341,923.00 for the Executive’s Department of Job and**
12 **Family Services, and declaring an emergency.**

13
14 Section 5101:9-6-82 of the Ohio Administrative Code authorizes counties to execute a
15 JFS 02719 “Inter-county Agreement and Certification Release and Acceptance of Funds” to
16 engage in inter-county transfers of funds allocated to county departments of job and family
17 services by the Ohio Department of Job and Family Services; and

18
19 WHEREAS, Section 5101:9-6-82(F)(2)(b) provides that a board of county
20 commissioners may assign authority to another party to serve as designee and therefore, grant
21 that party authority to sign an inter-county adjustment agreement on behalf of the county for a
22 specific period of time; and

24 WHEREAS, this Council previously adopted Resolution No. 2017-214, which authorizes
25 the County Executive to execute the JFS 02719 Inter-county Agreement and Certification
26 Release and Acceptance of Funds, and any other documents necessary pursuant to Section
27 5101:9-6-82 for the acceptance by the County Executive’s Department of Job and Family
28 Services (“SCDJFS”) of inter-county transfers of funds from other Ohio counties, for the period
29 6/14/17 through 6/30/19, and assigns the County Executive as designee of the County of Summit
30 to execute said agreements and documents as provided in Section 5101:9-6-82(F)(2)(b), for the
31 period 6/14/17 through 6/30/19; and

33 WHEREAS, the County of Summit and the County of Montgomery wish to enter into an
34 agreement pursuant to Section 5101:9-6-82 pursuant to which SCDJFS will transfer up to
35 \$100,000.00 in FFY18 Title XX Base federal dollars to the Montgomery County Department of
36 Job and Family Services (“MCDJFS”), in exchange for up to \$300,000.00 of FFY18 Temporary
37 Assistance for Needy Families (“TANF”) Regular federal dollars, which will fund prior year
38 TANF expenditures or be transferred to Summit County Children’s Services; and

40 WHEREAS, the County of Summit and the County of Allen wish to enter into an
41 agreement pursuant to Section 5101:9-6-82 pursuant to which SCDJFS will transfer up to
42 \$7,471.94 in FFY18 Title XX Base federal dollars to the Allen County Department of Job and
43 Family Services (“ACDJFS”), in exchange for up to \$41,923.00 of FFY18 Temporary
44 Assistance for Needy Families (“TANF”) Regular federal dollars, which will fund prior year
45 TANF expenditures or be transferred to Summit County Children’s Services; and

47 WHEREAS, while Resolution No. 2017-214 authorizes the Executive to accept the
48 transfer of funds to SCDJFS, it is necessary to authorize the Executive to execute an agreement
49 and any other documents necessary for the inter-county transfer of up to \$107,471.94 in funds to
50 MCDJFS and ACDJFS; and

5 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
6 that it is necessary and in the best interest of the County of Summit to authorize the County
7 Executive to execute the JFS 07219 Inter-county Agreement and Certification Release and
8 Acceptance of Funds, and any other documents necessary pursuant to Section 5101:9-6-82 for
9 the transfer of up to \$100,000.00 in funds to MCDJFS, and up to \$7,471.94 in funds to ACDJFS;

11 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
12 of Ohio, that:

14 SECTION 1

15
16 The County Executive is hereby authorized to execute the JFS 02719 Inter-county
17 Agreement and Certification Release and Acceptance of Funds, and any other documents
18 necessary pursuant to Section 5101:9-6-82 for the transfer by the Summit County Department of
19 Job and Family Services (“SCDJFS”) of up to \$100,000.00 in FFY18 Title XX Base federal
20 dollars to the Montgomery County Department of Job and Family Services (“MCDJFS”), and up
21 to \$7,471.94 in FFY18 Title XX Base federal dollars to the Allen County Department of Job and
22 Family Services (“ACDJFS”).

24 SECTION 2

25
26 This Resolution is hereby declared an emergency in the interest of the health, safety and
27 welfare of the residents of the County of Summit and for the further reason to immediately
28 authorize the transfer by SCDJS of said funds to MCDJFS and ACDJFS.

30 SECTION 3

31
32 Provided this Resolution receives the affirmative vote of eight members, it shall take
33 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
34 effect and be in force at the earliest time provided by law.

38 It is found and determined that all formal actions of this Council concerning and relating
39 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
40 deliberations of this Council and of any of its committees that resulted in such formal action,
41 were in meetings open to the public, in compliance with all legal requirements, including Section
42 121.22 of the Ohio Revised Code.




