7 **A Resolution authorizing the County Executive to execute a Subgrant Agreement with the**
8 **Summit and Medina Workforce Area Council of Governments, to provide Wage Pathways**
9 **pilot program services, funded through a United States Department of Labor Workforce**
10 **Innovation Fund grant awarded to the Ohio Department of Job and Family Services, in an**
11 **amount not to exceed \$807,480.00, for the period 8/21/17 through 6/30/19, for the**
12 **Executive's Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, on 9/26/15, the United States Department of Labor ("DOL") awarded a
15 Workforce Innovation Fund grant to the Ohio Department of Job and Family Services
16 ("ODJFS") to pilot a Wage Pathways program ("Project") service delivery model for the period
17 10/1/15 to 9/30/19; and

19 WHEREAS, the Proposal submitted by ODJFS to the DOL for the Project included Ohio
20 Local Workforce Area 2 ("Area 2"), specifically Summit County, as one of the workforce areas
21 in the State of Ohio that will pilot the Project; and

23 WHEREAS, the Summit and Medina Workforce Area Council of Governments
24 ("SAMWA COG") has entered into a subgrant with ODJFS whereby the SAMWA COG will be
25 the subrecipient of the Project funds for Area 2; and

26
27 WHEREAS, the Subgrant Agreement between ODJFS and the SAMWA COG to
28 administer the Project in Area 2 for the period commencing 8/27/17 and ending 6/30/19 includes
29 a Project allocation not to exceed \$807,480.00; and

31 WHEREAS, the SAMWA COG desires to enter into a Subgrant Agreement with the
32 County of Summit Department of Job and Family Services ("CSDJFS") whereby CSDJFS will
33 provide Project services on behalf of the SAMWA COG for Area 2, specifically in Summit
34 County, for the period of 8/21/17 to 6/30/19, in an amount not to exceed \$807,480.00; and

36 WHEREAS, this Council finds and determines that it is necessary and in the best interest
37 of the County to authorize the County Executive to execute the aforementioned Subgrant
38 Agreement to provide Project services on behalf of the SAMWA COG in Area 2.

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

45 The County Executive is hereby authorized to execute a Subgrant Agreement with the
46 Summit and Medina Workforce Area Council of Governments, to provide Wage Pathways pilot
47 program services, funded through a United States Department of Labor Workforce Innovation
48 Fund grant awarded to the Ohio Department of Job and Family Services, in an amount not to
49 exceed \$807,480.00, for the period 8/21/17 through 6/30/19.
