7 **A Resolution authorizing the County Executive to advertise for bids for the State Route 18**
8 **Walkway Project, located in Bath Township, in Council District 5, for an estimated total**
9 **cost not to exceed \$ 321,942.07 for the Engineer, and declaring an emergency.**

11 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
12 requires this Council's authorization for the County Engineer to advertise for bids; and

13
14 WHEREAS, the County Engineer and Bath Township have determined that there is a
15 public need for a walkway along the northside of State Route 18 just east of Interstate 77 to
16 Cleveland Massillon Road, in Bath Township, in Council District 5 (the "Project"); and

17
18 WHEREAS, the Engineer estimates the total cost of the Project to be \$321,942.07, with
19 the cost to be paid from Federal Transportation Alternative Program dollars and Bath Township
20 funds, and the Project will be administered by the Engineer's office; and

22 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to advertise for bids for the
27 State Route 18 Walkway Project.

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The County Executive is hereby authorized to advertise for the State Route 18 Walkway
35 Project, located in Council District 5, with an estimated cost not to exceed \$321,942.07.

37 SECTION 2

39 This Resolution is hereby declared an emergency in the interest of the health, safety, and
40 welfare of the residents of the County of Summit, and for the further reason that it will
41 immediately promote the safety of pedestrians walking along State Route 18 in Bath Township.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.


