7 **A Resolution authorizing the County Executive to execute a one-year intergovernmental**  
8 **agreement with the Summit County Combined General Health District d.b.a. Summit**  
9 **County Public Health for the County Sheriff's Office to provide after-hours security by**  
10 **Sheriff's Deputies during Summit County Public Health's after-hours programs, for the**  
11 **period 1/1/19 through 12/31/19, for payment in the total amount not to exceed \$41,749.00,**  
12 **for the Sheriff, and declaring an emergency.**

13  
14 WHEREAS, the County and the Summit County Combined General Health District d.b.a.  
15 Summit County Public Health wish to enter into an intergovernmental agreement pursuant to  
16 which the County Sheriff's Office will provide after-hours security by Sheriff's Deputies during  
17 Summit County Public Health's after-hours programs located at 1867 West Market Street,  
18 Akron, Ohio 44313 and 1400 S. Arlington St. #28, Akron, Ohio 44306, in Council Districts 4  
19 and 6, for the period 1/1/19 through 12/31/19; and

21 WHEREAS, Summit County Public Health has agreed to pay the hourly pay and fringe  
22 benefits of the Sheriff's Deputies, in the total amount of \$34,580.00 in hourly pay and fringe  
23 benefits in the total amount of \$7,169.00, for a total amount not to exceed \$41,749.00; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
26 that it is necessary and in the best interest of the County of Summit to authorize the County  
27 Executive to execute said intergovernmental agreement with Summit County Public Health for  
28 the aforementioned reason;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
31 of Ohio, that:

33 SECTION 1

35 The County Executive is hereby authorized to execute a one-year intergovernmental  
36 agreement with the Summit County Combined General Health District d.b.a. Summit County  
37 Public Health for the County Sheriff's Office to provide after-hours security by Sheriff's  
38 Deputies during Summit County Public Health's after-hours programs located at 1867 West  
39 Market Street, Akron, Ohio 44313 and 1400 S. Arlington St. #28, Akron, Ohio 44306, in Council  
40 Districts 4 and 6, for the period 1/1/19 through 12/31/19, for payment in the total amount of  
41 \$34,580.00 in hourly pay and fringe benefits in the total amount of \$7,169.00, for a total amount  
42 not to exceed \$41,749.00.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and  
47 welfare of the residents of the County of Summit, and for the further reason to immediately  
48 authorize an agreement with Summit County Public Health pursuant to which the Sheriff's  
49 Office can provide after-hours security by Sheriff's Deputies during Summit County Public  
50 Health's after-hours programs effective 1/1/19.

16 121.22 of the Ohio Revised Code.


