7 **A Resolution confirming an award by the Board of Control of a renewal (third of four) of a**  
8 **purchase contract with Aramark Correctional Services, LLC for food services at the**  
9 **Summit County Jail and the Glenwood Jail, for a one-year term, from 12/1/18 through**  
10 **11/30/19, for a total amount not to exceed \$750,000.00, for the Sheriff, and declaring an**  
11 **emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2015-458, which  
14 confirmed an award by the Board of Control of a purchase contract with Aramark Correctional  
15 Services, LLC to provide food services at the Summit County Jail and Glenwood Jail, for a one-  
16 year term, from 12/1/15 through 11/30/16, with four options to renew for an additional one-year  
17 term, in an amount not to exceed \$700,000.00; and

19 WHEREAS, the Board of Control, at its meeting held November 28, 2018, awarded a  
20 renewal (third of four) of a purchase contract with Aramark Correctional Services, LLC for food  
21 services at the Summit County Jail and the Glenwood Jail, for a one-year term, from 12/1/18  
22 through 11/30/19, in an amount not to exceed \$750,000.00, subject to approval by County  
23 Council; and

25 WHEREAS, County Council finds and determines, after reviewing all pertinent  
26 information that the renewal of the aforementioned purchase contract with Aramark Correctional  
27 Services, LLC, is necessary and in the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

32 SECTION 1

34 The award by the Board of Control of a renewal (third of four) of a purchase contract  
35 with Aramark Correctional Services, LLC for food services at the Summit County Jail and the  
36 Glenwood Jail, for a one-year term, from 12/1/18 through 11/30/19, in an amount not to exceed  
37 \$750,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
38 purchase contract.

40 SECTION 2

42 This Resolution is hereby declared an emergency in the interest of the health, safety and  
43 welfare of the residents of Summit County, and for the further reason to immediately provide for  
44 the food service to inmates at the Summit County Jail and Glenwood Jail.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take  
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.




