7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, authorizing purchases by the County Executive from Conrad's Tire Services Inc.,**
9 **as a Best Practical Source, for operations within the Sheriff's Office in calendar year 2018,**
10 **in a total aggregate amount not to exceed \$80,000.00, for the Sheriff's Office, and declaring**
11 **an emergency.**

13 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
14 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar
15 year, where no additional competitive quotes or bids have been taken, shall be made only upon
16 authorization of County Council; and

17
18 WHEREAS, the Department of Finance and Budget and the Board of Control have
19 previously approved purchases by the County Sheriff from Conrad's Tire Services Inc., as a Best
20 Practical Source, for operations within the Sheriff's Office in calendar year 2018, in a total
21 aggregate amount less than \$50,000.00; and

23 WHEREAS, the Sheriff's Office anticipates making additional purchases from Conrad's
24 Tire Services Inc., during calendar year 2018 and requests that Sheriff's Office be authorized to
25 make purchases from Conrad's Tire Services Inc., as a Best Practical Source, for operations
26 within the Sheriff's Office in calendar year 2018, in a total aggregate amount not to exceed
27 \$80,000.00; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary, and in the best interest of the County to authorize purchases by the County
31 Sheriff from Conrad's Tire Services Inc., as a Best Practical Source, for operations within the
32 Sheriff's Office in calendar year 2018, in a total aggregate amount not to exceed \$80,000.00;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 This Council hereby authorizes purchases by the Sheriff's Office from Conrad's Tire
40 Services Inc., as a Best Practical Source, for operations within the Sheriff's Office in calendar
41 year 2018, in a total aggregate amount not to exceed \$80,000.00.

45 This Resolution is declared an emergency in the interest of the health, safety and welfare
46 of the residents of the County of Summit, and for the further reason to immediately authorize
47 necessary purchases for operations within the Sheriff's Office in calendar year 2018.
